I. Purpose

The purpose of this Request for Proposals (RFP) is to enter into a contract with a qualified Certified Public Accountant to conduct an annual audit of financial transactions and accounts kept by or for the District, for the (5) year(s) ending June 30, 2024 through June 30, 2028, and to complete the Uniform System of Financial Records for Arizona School Districts (USFR) Compliance Questionnaire (CQ).

II. Scope of services required

The selected audit firm will be required to perform an annual audit, in accordance with U.S. generally accepted auditing standards and Government Auditing Standards (GAS), issued by the Comptroller General of the United States, and issue the reports required by those standards. In addition, the audit firm must complete a USFR CO in accordance with the instructions the Arizona Auditor General prescribes.

We had done this teacher retention payment before using the ESSER funding (Covid) but that funding has now ended.
